Now, however due to powerful global economic, political and demographic tendencies tensions between social and economic interests and values are increasing. Law and the "Sharing Economy"-Derek McKee 2018-11-27 Controversy shrouds sharing economy platforms. Together, the chapters offer a rich variety of insights on the regulation of the sharing economy, both in terms of the traditional areas of law they bring to bear, and the theoretical perspectives that inform their analysis. Civil society plays no less important a role in protecting the greater good of social cohesion. In short, both state and civil society need to consider future health policy in such a way as to overcome the inefficiencies of the past and make full use of the opportunities offered by science and technology to improve people's quality of life.
